
The Familiar Made Digital

The platform has digitized over 16 lakh paper sheets across 15 hospitals in Karnataka, including major cities like Bengaluru, Shivamogga, Davanagere, Chitradurga, and Haveri. This expansion happened largely through word-of-mouth, the strongest testament to a product that truly works. The numbers tell a compelling story: hospitals using DScribe have operational costs by up to 60%, dramatically cut patient discharge times, and freed up valuable space previously used for physical file storage.


